#### **Minutes**

- I. Meeting begins & introductions Lewis called the meeting to order at 11:00 AM with introductions
- II. Reading and approval of October 5, 2022, and October 21, 2022, special email meeting minutes Minutes were sent out prior to the meeting.

 A motion was made by Miller, seconded by Murphy to approve both October 5, 2022, regular meeting minutes and October 21, 2022, special email minutes. Carried.

#### **III. Correspondence** – None.

- IV. Treasurer's report Miller emailed the report in advance of the meeting and reviewed the Treasurer's report. Reports were updated for State Fair and Certificate Programs. Kierst just handed Miller approximately \$2,000 from the golf tournament. Stewart asked how much the golf tournament profited. Miller stated around \$2,000. Lewis thanks Kierst for organizing the golf tournament. Another \$25,000 was recently deposited from Monroe County for the Four-Hour Online Course, making this the fourth chunk of \$25,000 since Monroe County took over in June. Hotel reimbursements from Conservation Skills went very well. A lot of Districts took advantage of this. Miller mailed out the registration stickers to Cuddeback for the new trailer.
  - A motion was made by Stewart, seconded by Aldrich to approve Treasurer's Report. Carried.

#### V. Reports

- i. Division Reports
  - 1. **Division I** Collins shared his report, appended to the minutes.
  - 2. **Division II** Cuddeback shared his report, appended to the minutes.
  - 3. **Division III** Dulanski reported all is good in Division III. She has received a few calls and conversations on District Law but nothing to be brought forward.
  - 4. **Division IV** Murphy shared his report, appended to the minutes. Murphy stated there's interest in zoom meetings or to call into our meetings. Lewis stated he has no problem with Districts calling in if they are just listening and not interrupting our meeting with questions and comments. Next meeting will be at the Double Tree in Syracuse and there will be a zoom meeting option for that as he believes there may be a lot of discussion concerning the District Law. Murphy also mentioned the solar panel installation issues. Lewis stated he attended a training a few weeks ago and DEC stated that it differed from region to region.
  - 5. **Division V** Ballou reported that three out of the five counties in her division have new staff. Turnover is a continued problem. Holding a division meeting in January. She thanked the Board for having the meeting in Franklin County. Miller thanked Ballou for herding the Division all the time. Stewart thanked Ballou for doing a fantastic job as Division Representative forwarding all the messages to everyone. Stewart reporting for Hamilton County would like to welcome Kate WhitKovits from Herkimer County that comes with 5 years of experience working for Conservation District. Held 2 RAMP trainings through Community Resiliency Grant. She thanks Franklin and Warren County SWCD for instructing these trainings on the pilot app for roadside assessments. Lenny completed a Warren Brook stream restoration project with natural stream design. For the first

- time used a fabric to keep water from filtrated into stream. This is a trout stream and he partnered with Karl Schwartz from Fish and Wildlife, NYSDOT, and their local highway departments. Total cost was \$70,000. Released our 2022 accomplishments and review. County has increased their allocations for next year. Held our 46<sup>th</sup> annual Conservation Field Days.
- 6. **Division VI** Aldrich reported that Washington County is working on plan of work for AgNPS Round 27 and CRF. A Division meeting is planned for December 16<sup>th</sup> at Saratoga Apple. Working on AEM. Several counties have questions and concerns on District Law. Lewis reported in Saratoga County he has lost his District Clerk and is looking for a new one. Aldrich stated that Morning Ag Clips, an online agricultural newspaper has job postings. If any District has a job posting, they can email Kate Ziehms at kate@morningagclips.com and she can put it on their website.
- 7. **Division VII** No report.
- 8. **Division VIII** Calabro share her report, appended to the minutes. Suffolk County is recovering from cyber intrusion. Lost all their files.

#### ii. Partnership reports

- 1. NYS SWCC- Luskin reported the Managers Meeting is scheduled for December 13,14 at the Double Tree in Syracuse. Topics on the agenda include SWCC updates, strategic plan, State Aid changes, Ag Protection Program information and O&A with program managers, climate discussion with a focus on CRF and future program expansion, District panel discussion on operations, including growth, capacity building, recruitment and retention, budgeting, and policies. As of now registration is closed and we have over one hundred participants registered. State Aid 2023 PMs are set, returning to a pre-COVID metric and percentages. Round 29 of AgNPS and Round 7 of CRF are planned to be discussed at the next TAC meeting, December 6<sup>th</sup> and will be brought to the SWCC at the December 20<sup>th</sup> meeting. The Climate Action Council will be voting on the approval of the Scoping Plan at their December 19<sup>th</sup> meeting. Chapters 15 and 19 that contain strategies for agriculture, forestry, and land use should have little changes. Many of these strategies call for District program expansion to scale up efforts to assist the agricultural and forestry sectors in meeting the CLCPA targets.
- 2. NYACD- Hurlbutt submitted her report, appended to the minutes. Lewis stated that the Class C Stream Bill has been passed and on Governor's desk. Stewart stated since the bill has been approved by both houses, she is disappointed in the lack of NYACD push to encourage the Governor one more time to veto the bill. Discussion was held on the District Law change issue and what CDEA should do. Lewis, Stewart, and Miller have sat in on a few zoom meetings with the group pushing these changes voicing their concerns and asking questions. At the last zoom meeting, both Miller and Lewis both stated that CDEA was not to be put on anything and they won't be involved if this group keeps pushing legislation on District Law. Lewis asked if CDEA should have any involvement. Kierst stated you should have a presence. Lewis asked if CDEA should pay a lawyer to review

the document and to pay someone to lobby for the association. John Santacrose, a past board member for Albany County SWCD, would be a great lawyer to seek counsel. Lewis will reach out to him on what we can and cannot do. Miller stated that we should develop our own document and submit to legislators with backings from Grange, Farm Bureau, and others. Miller stated that NYACD is our legislative lobby governing body and Division board members need to attend Legislative Days. Lewis thanked Miller for sitting on zoom calls. He has sat on a few of them and has told them repeatedly that we do not support this, and we do not want our name as a stakeholder or supporter. NYACD needs to do more. More District personnel need to sit on zoom meeting calls who can answer questions that NYACD does not really know the answers to. Aldrich stated that NYACD has a bunch of open representative spots which concerns her. She asks how they can get anything done. Miller suggests holding district director zoom meeting on these changes and what a huge problem this. Every page of the sixteen-page District Law has a change. Aldrich suggests bullet the changes and how these will affect directors. Stewart stated that district directors will be gone, and academia and this group will be on the boards. Kierst thanks Stewart for her passion. Stewart suggests sending all district directors an email asking them to send to Blanche and cc Sam to say how disturbing this is. NYACD needs to get it together and support CDEA on this. Murphy suggested Lewis to send out bullets out to Division Representatives for them to distribute. Hago suggested developing a short video clip to be played at district board meetings. Kierst suggested that Hurlbutt go to Albany in January with a small group to voice concerns on this

- 3. NRCS- No report. Dulanski reported she received an email from NRCS asking for how many districts are collocated and how many have signed MOA's. Miller stated she received an email from Glover asking if CDEA is interested in receiving money for administrative fees for gardens and hi tunnels. Lewis stated he wants more information.
- 4. **MOA Discussion** Lewis stated there will be a meeting at the Managers Meeting in December.

#### VI. Committee/meeting reports

- i. Conservation Skills Workshop-. Lewis reported nothing to report. Ballou stated that next year needs to be discussed on where to hold the event. Murphy suggested Auburn hotel for it. They changed their hotel rooms that is now too small for WQS but would work for Conservation Skills Workshop
- ii. **Envirothon Committee** Miller stated committee is working on getting donations and a location for state Envirothon. Hobart is renovating one of the dorms and will not be available for 2023. For 2024 location must be changed as NCF will be held at

- Hobart. Working on a bid package to send out for locations. Looking for volunteers and funding.
- iii. Frank Bratt Scholarship Collins submitted his report, appended to the minutes.
- iv. **State Fair Committee** White reported nothing new. Miller stated it was nice to see all the employee volunteer winners that went out. All volunteers who man the CDEA booth are put in a drawing and five lucky names are drawn to receive \$50. White stated someone in Steuben County won the weight of the soil. She is coordinating with Steuben County to get the Ronny Raindrop beach towel to winner. She is planning to develop a QR code that people can scan that will direct them to CDEA website listing all the county districts and their website. Lewis stated the new trailer has been purchased.
- v. **Env Education Foundation Comm** Miller stated next meeting is in 2 weeks. Trying to get funding. What are the solar or renewable energy projects in each county. If counties have any projects in their county, please let Miller who the company is working on them. Calabro asked if a list of the companies who have donated. Miller stated no one has donated but she will send out the list of who the committee has sent donation request packets to. Stewart reminded everyone about Amazon Smile.
- vi. **NEACD** No report.
- vii. NACD No report.
- viii. **NYS Invasive Species Advisory Committee (ISAC)** Stewart reported she attended the joint Invasive Species Advisory Committee and Invasive Species Council meeting on October 18. Highlights included presentations on the DEC's forest health diagnostic lab, elm zig zag sawfly and mute swans. CDEA is not included on the agenda to give an update and she will address this in 2023. Lewis asked if he should send a letter addressing this issue.
- ix. Municipal Assistance Sub Committee Lewis reported still no meeting scheduled. Ryan Cunningham and PJ Emerick are working on it. Murphy stated that Cortland County and Tioga County would like to attend the next meeting to discuss solar installation concerns related to erosion and water management. Lewis stated MS4 inspector training program needs to be addressed as well as the new permit will be coming out next year.
  - x. Operations Manual Committee Lewis reported nothing new.
- xi. TAC Lewis reported next meeting is next week to discuss AgNPS Round 29 and CFR Round 7. AgNPS will have \$13.5 million available with anticipation of RFP come out in January with proposals due in April and ranked list in July/August by state committee. Buffer points for proposals is an issue. Counties are getting extra points for buffers to be installed but some are not installing them, and nothing is being done to them. Nothing will change for this round. AgNPS is PWL based, and sheets have changed. No source of pollution is listed on the sheets which is needed for proposals. Cuddeback stated a bunch of waterbodies are unassessed and have been for a long time. Lewis stated this will be discussed at the next meeting. CRF will have \$15 million available. Making changes to all the tracks. Murphy stated that some practices do not fit the catalogue. Lewis stated that about everything can fit in CRF. Last TAC meeting minutes are appended to the minutes.

- xii. Admin. Training Lewis reported he received one nice review from Division 1 and very few complaints that it was too short of a notice. Three bids were received from hotels and Double Tree won. Suggested to find a new venue to move it around the state. Will start planning for 2023 with training to be held around the same time as these years. Lewis stated that Vice President oversees WQS, and Cortland County has overseen the Conservation Skills workshop for forever. He thinks someone else should coordinate the Administrative Training. Ballou suggested that either the Secretary or the Treasurer should take this role over. Burke offered to assist planning this training and suggested Secretary take this role over.
- xiii. **Recruitment and Retention** Stewart reported nothing new is happening.

#### VI. Old business

- a) Update for CDEA stormwater online 4 hr. course White shared the report, appended to the minutes. Has 122 registrants for \$30,500. Mailed two checks to Miller for CDEA for \$25,000 each. Miller appreciates White for taking care all the questions emailed to her. White reported that Blackboard is the only company that responded to the RFP for moving the platform. Universities and colleges use Blackboard and White is confident they can move the platform. Blackboard uses Stripe which is like Square but since they already have a Square account, Emerick and White felt an additional \$12,000 to incorporate into the program would be money well spent. Lewis asked what the timeframe would be. White stated they estimate it to be from a few weeks to a few months. They are waiting to hear from White whether to start. Calabro asked if the cost of setting this up was for only one training or could we add more. White responded only this training, as others would cost more because they must add the videos to the platform. Murphy asked what our current cost is for the platform training is on. Miller stated nothing except for the space it takes up. Lewis asked what the workload would be for White if we went with Blackboard. She said a lot less as this should be a very self-sufficient run program. If current program crashed, we would be in trouble. She can go in and change something but as for coding she does not know how. If something needs to be changed or goes wrong White and Miller work together to fix it. She would be responsible to send emails to reset registrant's password and record sales receipts. Blackboard will take care of all the training and certificates. Fees for this platform will start the date of signup and maintenance fee will be charged yearly from that date. Lewis stated we should check with NYSDEC if we change the number format on the trainer cards to see if they are good with it. White said she will look into it. Ballou asked if District employees would still get this training for free like currently. Miller and White stated there must be a way to do this. White will ask them.
  - A motion was made by Miller, seconded by Stewart to move forward with hiring Blackboard to move Four Hour Online Course platform as soon as Kristin White learns if the fee schedule is the same and to approve the 2023-2024 maintenance fee. Carried.

- b) NYS ESC Certification Lewis stated that he spoke to Jessica Verrigni, and she is in the middle of renewals. She is leaving Chemung County SWCD to work at Schuyler County SWCD. Chemung County SWCD and Schuyler County SWCD agreed to shift the contract from one district to the other. Another training in Ulster County is being discussed.
- c) **2 hr. NYS DEC MS4 inspector training program for Districts -** No movement until new MS4 permit is issued.
- d) **2023 WQS** Stewart reported that track committees continue to submit course descriptions.
  - A motion was made by Miller, seconded by Calabro to approve a Drone 101 class instructed by Nick Freedman for instructor fee of \$1,000 and meals. Carried.

Stewart continued that volunteers are interested in organizing the Farmers Market and Resource Fair. Miller and Stewart met with Linda at the Double Tree Hotel to coordinate meals. Charge for Water Quality Symposium is as follows: \$520 for full conference and single room full week, \$420 for full conference and double room full week, \$75 for Tuesday or Friday classes, \$115 for Wednesday or Thursday classes, \$120 a night for single room, \$105 per night for double room, \$20 for Breakfast, \$35 for Dinner and \$50 for Banquet. Stewart suggested a coupon code for one person per district to go the full week to Water Quality Symposium for free. Miller stated this is not an issue to do. If a county does not have an employee going for the full week they can talk. Dulanski asked how much Four-Hour Online funds would be used for WQS. Miller stated no more than \$34,000. Lewis stated this is a good compromise. Stewart stated this will benefit all because the single and double fees for the whole week have been reduced.

• A motion was made by Dulanski, seconded by Ballou to approve the fee schedule for the 2023 Water Quality Symposium. Carried.

Stewart suggested hiring a bouncer for hospitality room since it is the first time together since Covid. Another concern is for underage drinking. Murphy suggested having registrants enter their birthdate on the registrations. Miller urges Division Representatives to send out reminders to members to send in registrations as soon as possible. It is going to fill up quick. Stewart stated college students will be allowed to attend classes for free same as last year. Aldrich reported that as of November 1<sup>st</sup> she received a quote from Griffin Greenhouse Supplies for fertilizer tablets for \$66.71 per box for sixty-five boxes. This quote was good for only 30 days. She suggests purchasing one hundred boxes. Kierst stated that Cayuga County has in the past had them delivered to their office and then trucked to Water Quality Symposium.

• A motion was made by Stewart, seconded by Miller to purchase one hundred cases of fertilizer tablets from Griffin Greenhouse Supplies. Carried.

- Warren County will take care of the meat, cheese, mustards for hospitality room. Lewis appreciates Murphy and Dulanski's work on silent auction items and virtual auction the past few years. Miller stated that no frozen items be accepted for the silent auction. There are no freezers available to store it. Calabro stated award nominations are coming in slowly. Ballou stated new employee gifts and service pins are plentiful but will need gifts for 25+ service recipients.
- e) Ronnie Raindrop Stewart debuted the costume at the October CDEA meeting and requested feedback from District staff. She relayed feedback to designer Liz Woods. Liz is now making alterations and will bring a new costume for Stewart's review in January. Then, remaining costumes will be made. Miller stated there's interest in Ronny Raindrop outreach products such as little Ronny figurines. Miller and Burke will order them.

#### VII. Other old business –

- 1. Murphy reported that the last Leadership Institute was attended in 2016 with twenty people attending. Ballou stated it was a wonderful experience and a great relationship building event. Murphy stated personality evaluations were performed and he learned a lot of tricks on public speaking. Next event planning is underway with the committee consisting of attendees from the last event. Looking at any week in July. Lewis asked if the venue is requiring Covid vaccines like they were in the past few years. Murphy will check. Lewis asked if there is a cost to districts to attend. Ballou and Murphy stated yes but not sure how much. Miller stated she is talking to DeWeese and has funding from NRCS for this. Leadership training will be added to Old Business for next meeting.
- 2. Miller stated that Franklin County has Rural Roads App outstanding bill for \$200 and was wondering if CDEA would pay it with Four Hour Online Funds. Lewis stated we should discuss the Four-Hour Online Funds forms. Dulanski reported she met with Calabro and Stewart to review the forms and comments from last meeting. They are fine with increasing from \$5,000 to 10,000 for the letter of award but do not recommend increasing the time from 12 months to 24 months to complete the training because CDEA wants quick turnovers and to get the money spent. She also stated they do not recommend hotel accommodations be reimbursed before the training. They recommend Districts to ask Division Representative to mention training at the CDEA Board Meeting as an application for attendance at a technical or educational workshop, for District employees to get hotel rooms paid for similar Conservation Skills Workshop. The committee is also recommending that since the policy for the use of Four-hour online funds was approved in March 2022, applications for trainings can be made then until March 2023 can be submitted for reimbursement after the trainings has taken place. After March 2023, all trainings will need to be preapproved. Kierst asked how much will be available. Dulanski stated no amount has been set yet, the committee was unsure how much Four-Hour funds would be available to use. Application will be google docs. Dulanski suggested that someone other than the President be responsible for reviewing the applications then send a preview of the application to the President for approval. The

committee believes that there may be many applications and the President is already busy with other CDEA responsibilities.

- A motion was made by Miller, seconded by Ballou to approve Four Hour Online Training Forms as recommended by the Committee. Carried.
- VIII. New business Lewis stated there is a problem getting new members to run for Vice President and other positions. Will be looking for a Vice President, Member At Large, Treasurer and any Division Representative in odd number Divisions that are looking to get off, but all positions are up for election except the even number Division Representatives. Suggested that Division Representatives send out an email encouraging people to consider becoming a board member. Hagar stated being on the CDEA Board as a nonmanager is helpful in building leadership skills.
  - a) Association Manager Duties Lewis suggested a small committee be formed and give report at next meeting. Anyone interested on being on committee email Miller or Lewis. Ballou asked what the budget is for this position. Lewis stated it has not been determined and will be something the committee will need to discuss. Murphy expressed his concern of hiring a manager that is not a current or former District Employee and attend meetings without the proper knowledge. Lewis stated that this Manager would not take over roles of the President and Vice President but assist them and he agrees with Murphy. Stewart suggests another solution is hiring an event manager to take over the Administrative Training, Water Quality Symposium and Conservation Skills Workshop instead of hiring an Association Manager. She wants ownership of reviewing the bylaws. She envisioned this in place of Association Manager and be part time. This person works from June to September on Conservation Skills Workshop, September to March on Water Quality Symposium and whenever to set up meetings. Ballou recommended to contact Division Representative in the county of next board meeting to order food, set up meeting venue and to find hotel for board members. Lewis stated this is an option and the committee should discuss this. If Division Representatives and other Board Members take on some of the responsibilities listed on our priority sheet of duties for Association Manager that would take some of the load off President and Vice President. Miller stated the bylaws should be looked at and see who should be responsible for what. Add responsibilities to other members of the board that the Vice President or President currently do. Kierst asked if there is a list of committees and what committees need members. Aldrich suggested send out proposals for bids for the position start small part-time and if it works do not change it. Miller suggests Division Representatives send emails to members with a write up of what was discussed and look for volunteers for whatever we need. After CDEA meeting Ballou and Miller jot down the important points of the meeting and email it out to their division members. Remember not all employees get an email from Maureen Irish. Committee for Event Coordinator/Association Manager includes Stoddard, Burke, Miller, Murphy, Dulanski and Cuddeback.
  - b) **Job Fair Presence at ESF** Miller stated there is an ESF Career and Internship Fair on February 16, 2023. Megan Webster from Ontario County brought forward this

opportunity for CDEA to attend. Cost is \$100 for nonprofit and \$200 profit. Aldrich asked if all the counties who have job opening announcements send them to one point person and they send it to ESF. Lewis stated this will be discussed more at the next meeting. He feels we should look at other college job fairs we can attend to. A subcommittee has been formed including Lamb, Zajac and Normandeau. Stewart mentioned that Megan Webster inquired of CDEA could pay for recruitment outreach items like banners. Anyone interested to participate on this subcommittee please email Lewis. Miller will add a line item for 2023 under Outreach for job fairs. Stewart suggested each Division Representatives pick one college in their division and see if there is interest or ability to table an event. Miller stated we need to make Ag Engineering cool. Aldrich suggested outreach at FFA convention. Luskin stated that Hurlbutt has a list of all the colleges in the state. Lewis will email her for the list.



# NYSCDEA November 30th, 2022 Division VIII Report Suffolk, New York City, Westchester, Putnam, Rockland, Nassau Counties

#### **Suffolk County: Ann Marie Calabro**

Outreach materials for the 2023 WQS Awards Banquet have been sent out. Nominations are coming in slowly. A recent cyberattack on the County left the District operating with little to work with. Despite not having phones, email, or files, we were still able to limp by on most projects.

Below is a list of some ongoing programs:

- Soil Health Sampling/Testing and Equipment Rental Program (Soil HELP): The district has been working with Suffolk County growers providing CASH tests and loan out several pieces of district owned equipment. Winding down as winter approaches.
- Ag NPS Grants: Ag Non-point Source Fuel Tank Round 24 & 26
   Fuel Tank inspections are beginning to take place on newly installed tanks as well as previously installed tanks. 14 tanks are still being installed. Roughly 39 farms participating in various stages.

Ag Non-Point Source Round 26 Corwin Duck Farm SBR Grant

New York State granted Suffolk SWCD funding to Corwin Duck Farm to replace their Sequence Batch Reactor that process waste from the ducks grown on the farm. Aqua-Aerobic Systems is projected to begin the installation of the new control panel shortly.

Ag Non-Point Source Round 27 Mecox Bay Dairy

Installation of a Slurrystore (Liquid Manure Storage) at Mecox Bay Dairy will have positive impact on water quality and the efficiency of the dairy's use of manure and overall farm operation. Awaiting geotechnical engineer to perform assessment.

- <u>DEC EBP Ag Handling Facilities:</u> Term extended to January 2026 for installation of Agrichemical Handling Facilities. Working with Tim Clark, NYS SWCC Engineer to certify pad designs. 1 complete, 1 installing, and 3 obtaining permits
- <u>2017 EPF:</u> Subcontract with CCE Suffolk. Cover Crop Cost Share: The goals of this program are to demonstrate and
  promote cover crop mixes and rotations to accomplish water quality and soil health objectives.
- <u>AEM:</u> Round 17 technical assistance and implementation projects have been approved and are getting underway. Projects include a prescribed rotational grazing system including a livestock pipeline for sheep, and a high efficiency irrigation water management system with microirrigation in a highly sensitive area.
- <u>High Efficiency Irrigation:</u> Microirrigation project including the installation of mainline, submains, and dripline for 10 acres of field stock.
- Outreach: Compost workshop series, 2023 Ag Forum Planning, 2022 Year in Review, Envirothon

#### New York City: Shino Tanikawa

We hosted the 7th annual Urban Soils Symposium on Governors Island. We are very proud of our art extension that connects artists with soil scientists for creative collaboration. We had several artists exhibit their work at the symposium to foster understanding of urban soils as well as provide new perspectives for research.

We were awarded a grant from the NYS Pollution Prevention Institute for a green infrastructure incentives public outreach project. We will be working in partnership with a Bronx based non-profit, DEP and the Green Roof Researchers Alliance. The target audience is private property owners.

#### Westchester County: David Kvinge

- <u>Beech Leaf Disease</u>: Over 2022, the District facilitated some successful reforestation projects associated with the impacts of beech leaf disease in County parks. We will continue some of that work, using Parks staff as well as volunteers to replace impacted beech trees with new native trees.
- <u>Living Shoreline Project</u>: We are in the permitting phase for our living shoreline project along the Long Island Sound at Edith Read Wildlife Sanctuary adjacent to Playland Park in Rye. We are hoping to get construction started in the spring.
- <u>Workshops</u>: We had a successful online workshop this past October on urban trees and their care and maintenance. The Board is working on a 2023 workshop, tentatively on resilient/regenerative farming.
- <u>Envirothon</u>: Building on the success of the 2022 Envirothon, we are in the planning stages for a similar 2023 event at Mountain Lakes Park again. Outreach to occur this fall.
- Watershed Planning: We are working with NYSDEC on some watershed plans focused on flood mitigation, through their
  Resilient NY program (<a href="https://www.dec.ny.gov/lands/121102.html">https://www.dec.ny.gov/lands/121102.html</a>). We have some funding for our own watershed
  plans and hope to plan on working more closely in 2023 with NYSDEC and NRCS staff to broaden the watershed plans
  and/or take them a step further towards project design and implementation.
- New Hires: We are getting close to refilling the vacancy left by retirement of long-time District Manager Rob Doscher
  this past June. We hope to have this position as well as another principal environmental planner position focusing on
  water quality and flooding filled by the end of the year.

#### **NYACD Report to CDEA – November 2022**

**Monthly Director Letter:** The October Director letter was completed and mailed at the end of the month to all districts and directors.

**Legislative Bill:** The Stream C bills have not been signed by the Governor's desk as of November 2022.

**Legislative Days:** The Hampton Inn – Wolf Road, 10 Ulenski Drive, Albany has been secured for Monday, March 6, 2023. There will be a meeting Monday evening at 7:30 p.m. NYACD once again will be hosting a table at the Farm Bureau "Taste of New York" event Monday evening.

I have been working on the Legislative Day registration packet to be mailed to the districts the first week of December. Waiting for a couple of things to complete the packet for mailing.

I'm working on the Legislative Booklet to showcase districts to the Legislators in pictures and words. Presently I've had nine (9) districts send in articles. I really want to showcase what districts are doing with the funds Legislators are supporting plus show them we are doing all the things that the Watershed Healthy Coalition wants changed in district law. To basically, gather their support to put a stop to any changes in district law because there is no need to.

**Potential District Law Changes:** I have completed a letter to be mailed to all the folks needed to support the districts against the Watershed Healthy Coalition in changing district law. Over seventy (70) letters went out to Ag & Mkts, Grange, Farm Bureau, the Legislative Environmental and Agriculture Committees. I've received newspaper articles and district support letters and shared them with the NYACD board before our November meeting.

I created a letter to districts to update them on what NYACD has done to stop the move forward regarding potential district law changes. The NYACD board felt this was a good way to show the districts what and how we are working on this issue. They went out the first part of this week (November 29, 2022) to districts and directors.

**4-Way Partner Meeting:** The next 4-Way Partner meeting will be held at the CDEA Managers meeting on December 13, 2023, at the Double Tree in Syracuse in the morning. At this meeting we can discuss the MOU with NRCS.

**2023 NYS Envirothon:** The NYS Envirothon held a meeting on Monday, November 21, 2022, by zoom. The committee is working hard, and things are moving along as expected at this time. We wanted to remind districts that the registration fee was increased for teams to \$600 due to the increase of cost to NYS Envirothon.

**2024 NCF Envirothon New York:** The NCF Envirothon NY meeting was held directly after the NYS Envirothon meeting on Monday, November 21, 2022. The committee's greatest concern is funding but are working hard to find funds to support this event. We have a little over \$50,000 of the over \$450,000 needed to fund this event.

<u>Welcome and Introductions, discussion of August 2022 meeting</u> – B. Bzduch welcomed everyone to the meeting. The notes from the August meeting were sent to the committee in advance. No discussion took place; however, any comments or questions can be directed to B. Bzduch.

**Round 29 Agricultural Nonpoint Source Pollution RFP** - B. Bzduch presented slides regarding the development of the request for proposals for Round 29 of the AGNPS program. She discussed that \$13.5 million would be made available to support projects through Round 29. This amount factored in various budgetary carve outs as well as AEM Base 17 TA Year 2. The Round 29 AGNPS RFP will be released jointly with the Round 27 CRF RFP. Tentatively, these RFPs will be released in January 2023 and AGNPS applications will be due in April 2023. If released in January, application scoring will take place in May/June 2023 and a ranked list could be presented to the NYS SWCC in July or August 2023.

- B. Bzduch mentioned that at previous TAC meetings, the group had discussed potential changes to the Riparian Buffer preference point structure which could include an incentive payment. This topic will be tabled for a future round of AGNPS funding. The Access Control/Riparian Buffer preference point structure will not change.
- B. Bzduch then discussed the requirement to give preference to proposals located within a watershed or sub watershed of priority waterbody as identified by the Commissioner of Environmental Conservation. The AGNPS RFP further defines what shall be considered a priority waterbody. Historically, the AGNPS program has prioritized projects that address waterbodies with a known agricultural source of pollution (as identified on the PWL). In 2021, the assessment method used to create the priority waterbody list was updated. Changes were made to the waterbody factsheets to reflect the new methodology. To accommodate these changes the NYS SWCC will need to revise our scoring structure to accommodate the changes. B. Bzduch discussed the differences between the previous versions of the fact sheets and the updated versions. One major difference is that the updated version no longer includes a source of pollution. Because that information is no longer available, we will need to adjust the scoring criteria. Bzduch shared some ideas to revise the scoring criteria. The first is to be more general and prioritize the waterbodies with a best use or overall waterbody assessment identified as "impaired". We could also focus on the type of pollutant identified in the PWL. P. Kaczmarczyk commented on the lack of information on the PWL and questioned how relevant the information is to more local data/observations. Paul commented that perhaps we should start moving away from PWL and focus on local data when prioritizing projects. B. Bzduch mentioned that some Districts share the same concerns, however, the NYS SWCC is mandated by law to give preference to projects that will address waterbodies on the PWL. We cannot move away from it completely, but we can work with the scoring criteria to allow Districts to use other sources of data to justify their projects. B. Rahm commented that it may be better to link to the pollutant rather than the best use being identified. If you can justify that your project will have some sort of benefit related to the pollutant that's identified that would be the strongest justification. He went on to state that a lot of applications talk about specific pollutants that they are trying to address. If a SWCD can demonstrate that the project will make an improvement on the current assessment that will be more important than over

prioritizing the concept of impairment. S. Latessa mentioned that her understanding is that the threshold to determine impairment has gone up significantly. This might mean more segments might be identified as "needs verification". She supports focusing on the pollutants. S. Fickbohm mentioned that a mapping tool might be good to help Districts focus their efforts. D. Lewis supports focusing on pollutant type, however, sometimes the pollutant of concern is not being caused by agriculture. D. Lewis requested that someone from DEC call into the next TAC to provide additional information on the status of the PWL updates. Action Item: Bethany will reach out to DEC to get more information on the PWL/waterbody assessment process. Bethany will also invite DEC to the next TAC meeting to be available to answer additional questions from the group.

Bethany highlighted changes that would be made to the Proposal Rating Sheet. Discussion took place regarding the wording of some categories. Bethany will continue to refine the language and present another draft at a subsequent TAC meeting.

**Round 7 Climate Resilient Farming RFP** – Brian Steinmuller presented some slides to discuss Round 7 of the Climate Resilient Farming program. Brian shared that approximately \$16.25 million dollars was appropriated to the Climate Resilient Farming program in the EPF FY 2022-2023 budget. For Round 7, it is recommended that \$5 million be allocated to Track 1, \$6 million to Track 2, and \$4 million to Track 3, for a total of \$15 million. Some funding should be held back and set aside for additional tool development and other types of projects that will advance our long term CRF efforts consistent with the CLCPA. Caitlin Stewart commented that this is a positive approach and appreciated the holistic watershed approach for Track 2. Brian presented a tentative timeline for CRF. The Round 7 RFP would be announced with the Round 29 AGNPS RFP in January 2023. The tentative due date for applications would be June/July 2023. A ranked list would then be presented to the State Committee in September 2023. The extended application period would allow Districts more time to learn about the expanded program and consider appropriate projects.

Track 1: Livestock Management: Alternative Waste Management & Precision Feed Management. Formally, this track focused on manure storage covers and flares. There is an opportunity to address methane reduction through various types of manure management/handling practices. This track would still prioritize the retrofit of existing manure storages with covers and flares. It is recommended that this track be expanded to allow additional methane mitigation practices such as: pasture-based management, compost bedded packs, solid separation equipment, precision feed management, etc. Manure treatment technologies (de-watering) and anaerobic digesters potentially eligible with a funding cap. S. Fickbohm mentioned that he is supportive of the funding caps. Brian discussed a tool used by California that is used to quantify emission reductions from many practices.

Track 2: Adaptation & Resiliency: Previously was Water Management, this track has been expanded over the course of the last few rounds. It is recommended that this track be further enhanced for Round 7. In additional to previously eligible BMP systems, prescribed rotational grazing, integrated pest management, weather monitoring systems/tools and green infrastructure systems would be eligible for cost share. This track would also include beneficial electrification projects (i.e., equipment related to frost fans, cow comfort). These projects would have to show a reduction in greenhouse gas emissions or energy conservation. B. Rahm asked for further explanation about the need for weather monitoring systems. B. Steinmuller stated that these types of systems would be necessary for farms to help them make management decisions. These could be part of a broader BMP system. These could be pest management or irrigation related. B. Rahm added that there are some existing tools out there and it would be good to get a sense of what is available already. S. Fickbohm suggested that there might be an opportunity to develop a tool that looks at watershed scale to identify flash flooding zones or erosion areas.

Track 3: Healthy Soils NY: This track will still focus on soil health systems, with the addition of agroforestry practices. Agroforestry practices could include tree/shrub establishment, structure for wildlife, conservation cover, critical area planting, or alley cropping. Custom applicator services are eligible for cost share for practice being implemented. The use of digital technologies, data collection and analysis to better quantify benefits, and adaptive management tools may be proposed as part of a soil health project. Outreach components are encouraged and eligible for 100% cost-share. Projects that include an economic analysis to aid the farmer in long-term adoption may include this as match to increase overall request. Funding of the analysis could also be included in an outreach event for farm-to-farm education. Outreach is eligible at 100% cost-share.

It was recommended that the TAC meet one more time before the RFPs are presented to the NYS SWCC.
