Description: Farms under 50 acres are one of conservation's biggest new customer base. Many operations are raising small numbers of diversified livestock, vegetables, fruits, bees and niche products for family use and direct to consumer outlets. They seek good advice from the business planning side to land management and BMP practice decision-making as well as targeted funding opportunities. This class will address what is a "defined" small farm, understanding the diverse needs, the skills, framework and tools needed to help. Staff will highlight their experiences using successful examples of projects or approaches that work consistently.

- Characterizing existing farm conditions (watershed scale, farmer goals, and site-specific assessment ala Tier 2);
- identifying resource concerns/opportunities;
- technical aspects of planning BMP systems and alternatives; and
- plan presentation and documentation.

The Six Thinking Hats technique stimulates clear, objective, creative thinking, and reduces the "trenching" of endless discussions and arguing. Applying this technique results in shorter, focused, results-oriented meetings where people want to participate. Participants effectively analyze issues, generate ideas, and make better decisions. The use of hats is a simple mental metaphor. Hats are easy to put on and to take off. Each hat is a different color that signals a unique thinking technique. In this half-day interactive class, we will identify the purpose of each hat color and apply the method to a variety of real-life scenarios at work and personal scenarios.

18. Addressing On-farm Manure and Imported Organic Nutrients
