Minutes

- I. Call to order President Stewart called the meeting to order at 12:04 p.m.
- **II. Introductions** Conducted.

- **III. Reading and approval of July 25-26, 2023 meeting minutes** The minutes were provided in advance of the meeting for review.
 - A motion was made by Cuddeback, seconded by Aldrich to approve the July 25-26,
 2023 meeting minutes. Carried.
- IV. Treasurer's report Kemmeren shared her report, appended to the minutes. Murphy asked if Leadership Conference funds were coming in. Kemmeren stated she in the process of invoicing NRCS \$3,000 and transferring \$3,000 from 4-Hour online fund for CDEA contribution. Murphy asked what the budget was for Division meetings. Stewart replied \$1,500 to be used before the 2024 CDEA annual meeting. This money can be used for instructor fees and food. Division Reps can set a date for a meeting and pull in an instructor for first aid and CPR, defensive driving, etc. Terrific way to train employees.
 - A motion was made by Cuddeback, seconded by Stewart to approve the Treasurer's Report. Carried.

V. Partnership Reports

a. New York State Soil and Water Conservation Committee – Bzduch shared her report, appended to the minutes. She stated that the tentative date for the NYS SWCC Advisory Member and Partner Project Tour in Ulster County will have to be changed as it conflicts with the 5-Stand Tournament. She presented timeline for AGNPS Round 30 with release of RFP later in the fall of 2024 and applications due January of 2025. Reasons for this is she has not started working on the RFP and there is a lot of funding and programs that are going on right now she does not want to bog the contracting system down any more than it is. Stewart asked what the historic timeframe was for AGNPS. Bzduch stated she believes RFPs were released in October/November and applications due January/February. Stewart stated she has heard from some Districts it is hard to have AGNPS RFP due as the same time as CRF. Murphy suggested that the timeline of AGNPS and CRF not coincide, so Districts are not wasting time writing grants for the same farm. Cuddeback stated it would be nice if the CRF and AGPS were due and awarded at contrasting times so if a farm doesn't get funding from one program they can apply for the other program. Halloran stated it is hard to write applications during field season. Aldrich stated delaying AGNPS Round 30 may alleviate the backlog of contracting.

Bzduch followed up on the question on solicitation guidance of Districts. She reached out to Dan to see if he could provide clarification on what he was referencing at the Administrative Conference. He provided her with a document that was put together by the Tug Hill Commission which applies to municipalities. District Law clearly states Districts can accept donations; but are Districts considered a municipality? She was unsure if SWCC could give clear guidance of whether Districts can solicit donations. She suggested contacting the attorney general for an official opinion on whether Districts are referred to as municipalities. Yaw asked if Dan stated if accepting donations would

be allowed in a District audit. Bzduch stated she did not ask him that specific question but did ask him about different scenarios and that Districts have been audited and she has not heard of any District being reprimanded for accepting donations. Halloran and Aldrich stated they do not believe Districts should be labeled as a municipality. Stewart stated we should let this be a grey area because if you pursue it, you then will have to abide by whatever is determined and that may not be what we want. She also stated what we are doing now is working and if you get audited, and you are in violation it is a reprimand, and you are told to fix it. Bzduch stated Steve Lorraine gave good guidance on this that should be shared with Board of Directors. She also suggested changing District Law that would allow soliciting for donations.

Operations Manual will be updated including the section where it states Districts can accept donations.

Stewart thanked Bzduch for all her guidance.

Knapp presented on simplifying the SW forms for AGNPS grant proposals on which he has been working. All forms will be in one worksheet with tabs. Trying to streamline the worksheets so there are less mistakes and there could be a budget and closeout information all in one worksheet. He stated changes are coming forward with the SW forms and asked Division Reps to get more feedback on them. Bzduch suggested that Districts who get awarded AGNPS or CRF funding to pilot these worksheets. Aldrich asked what SWCC needs from these forms to report to State. Bzduch stated just the total dollar amounts. Cuddeback stated at his Division II meeting Districts liked the SW forms in one worksheet. He liked using auto fill and not worrying about mistakes. Knapp will forward worksheet to Stewart to send out to Division Reps to seek Districts to pilot this.

- b. New York Association of Conservation Districts Hurlbutt shared her report, appended to the minutes. Murphy stated in the last correspondence Hurlbutt sent out there were vacancies on the NYACD Board. He encouraged Division Reps to look and see if there's a vacancy in their Division and to encourage District Managers to think about seeking anyone on their Board to fill the vacancy.
- c. Natural Resources Conservation Service No report submitted.

VI. Division Reports

a. **Division I** - Campbell shared her report, appended to the minutes.

Katie Pfeifer, Niagara County SWCD entered the meeting at 1:25 p.m.

Pfeifer answered questions on the QuickBooks consultant application through 4-Hour Online Funds. If someone has a question, they should check the outdated QuickBooks Manual. If this does not solve the problem, they should then check with Yaw or Judy Bennett and if they cannot answer the question, they would call Pfeifer who would contact the consultant. Stewart suggested if Pfeifer notices the funds getting low as the year nears the end to submit another application. Pfeifer mentioned her county SWCD is

not interested in housing this program. Stewart stated a District will need a point of contact, to house the program, and pay funds upfront and then CDEA will reimburse the District. Campbell will see if Wyoming County SWCD will run the program with Pfeifer as the point of contact. Lewis stated Saratoga County SWCD might be interested in running the program but would have to run it by the Board. Campbell stated she will talk to her District Manager in the morning to see if this is something the District would be interested in. It may have to go to the board for approval. If not, she will get into contact with Lewis.

Pfeifer left the meeting at 1:30 p.m.

- b. **Division II** Cuddeback shared his report, appended to the minutes. Cuddeback mentioned the need for more volunteers for the State Fair Booth as counties that were nearby (Cayuga, Monroe, and Oswego) had to fill multiple shifts that no one volunteered. The State Fair Committee would like to see more participation across the state. Stewart stated that State Fair Committee will comp rooms for two people who work two shifts, all volunteers get a free t-shirt, free parking pass, and name put in a raffle. She stated that White had mentioned that it is an expectation that should be written in the By-Laws that all Executive Board members volunteer for a shift. Halloran, Yaw and Kemmeren stated by the time the schedule went out all day shifts were taken. Murphy stated there was a sign-up sheet in the binder at the booth to sign up next year. White stated she could send out the sign-up sheet earlier. Stewart stated the State Fair Budget should be increased for next year when the budget is reviewed in November.
- c. **Division III** Yaw shared her report, appended to the minutes. She mentioned holding a trailer training but has questions of where to hold it, whether it should be a Division wide or statewide training, what training needs do employees need and dates. Details are being worked out. She will be sending out a questionnaire Division wide for feedback on this training.
- d. Division IV Murphy shared his report, appended to the minutes. Murphy mentioned earlier discussions on the CRF carve outs questions and policy development. A couple of years ago a subcommittee was formed to discuss CRF program. Bzduch stated she hopes the new advisory committee will be able to talk about new, current, and past grants and to get feedback from Districts on how to make them better. State Committee sets money aside for special projects and money be carved out for research. Murphy stated he has heard that Districts might partner with researchers for projects that they are already applying for or researchers who are already getting money could involve the District. Kelly stated that research projects are going on that Districts are not involved with, and when results are released, Districts do not have knowledge or familiarity with this research to implement it. She suggested working alongside the researchers on projects that Districts are familiar with instead of being told what we need to be doing. Steer the ship more on local needs. Cuddeback agreed with Kelly and stated he works with Cornell a lot on Cover Crops. There's room for more opportunity he is sure, but we need to find those contacts. Aldrich stated there could be some shared internship opportunities there.
- e. **Division V** Stoddard shared her report, appended to the minutes.

- f. **Division VI** Aldrich reported Washington County SWCD is closing out a couple of AGNPS grants, submitted 3 CRF and 2 AGNPS applications, and completed a VTA. Working on planning for AEM. Performed outreach at their local fair and chatted with Commissioner Ball. She staffed the State Fair booth on Labor Day and talked to 4-5 people in various stages of life interested in what District do and if hiring. Through CRF Round 5, they purchased an interseeder that will be used this fall. Nationwide Insurance, Cargill Seed and Pioneer Seed sponsored a successful grain bin safety training with thirty-five firefighters from five fire departments that was very well received. News Channel 5 and a Legislator were in attendance. She thanked Klemczak for hosting and helping with the site. Lewis reported that on October 5th a 4- hour erosion and sediment control class will be held. He also has the permit administrator coming to their office in the beginning of October to go over the general permit and the Upper Hudson Counties will be included in the meeting as well.
- g. **Division VII** Ferry shared his report, appended to the minutes.
- h. **Division VIII** Vacant position. Stewart thanked Ben Luskin for assisting in searching for someone to fill the position. The interested person plans to attend the November meeting to see if it will be appropriate for her schedule.

VII. CDEA Standing Committees

a. Accept 2023 CDEA Committees – Reviewed the committees for changes to be made. Murphy stated that when we update the bylaws it is important to capture that the State Fair and Empire Farm Days have become their own standalone committees and not Division Rep II, III, and IV Responsibilities. Under Water Quality Symposium Committee Lewis asked if Ed Henry was back in NY as an NRCS Partner. Leadership Institute will be held every 3 years not four. Civil Service Administrative Management Committee Member at Large manages this and can recruit committee members. Stewart suggested Halloran to contact Doug Kierst to give her more information on the Management Development Certificate Program. Ferry will chair the Sunshine Fund. CDEA 5-Stand Tournament - add Russell Smith as a Committee member. Fish On Challenge - Stoddard asked to add the following members: Jim Lieberum, Dustin Lewis, Kristin Ballou, and Maren Stoddard. White asked about adding a District member to the advisory committee of the NYS Envirothon. Lewis stated that advisory members do not have voting rights and he agrees with White that a District staff member should be an advisory member. He also stated that according to the CDEA By-Laws the Envirothon Committee vote on who are its advisory members. Halloran suggested at the next Envirothon meeting, all committee members need to announce who they represent. White asked if there are enough voting members and that she wished there were more representation from Districts. She stated the By-Laws are old and should be updated since some of the affiliations do not have representation. Stewart stated if the By-Laws

on this section need to be updated to please let her know so it can be worked on in November. Halloran stated there is a lot of work and only a quarter of the people know how to do it. Kelly asked if there was someone willing to be the chair. Lewis stated it needs to be someone already on the Board. Halloran stated that only 6-8 people attend a meeting. Stewart asked if minutes were posted on the Envirothon website. Kemmeren stated no. Halloran stated she will take the CDEA By-Laws to the next Envirothon Meeting. Murphy stated this needs work and more work than what can be managed at this meeting. Lewis stated that on the Envirothon application, a box should be checked stating their affiliation. Murphy suggested a letter from the affiliation they claim to be represented stating they approve this person as their representative. Kemmeren suggested it be discussed and decided by affiliation who the voting member be. Stewart stated we will hold off on approving Envirothon Committee until November meeting to see who the voting members are. Kemmeren stated the next meeting will be at SUNY Cortland. Lewis suggested sending an email out statewide announcing the next Envirothon meeting so interested folks could attend. SWCC Municipal Assistance Sub-Committee - add Halloran as an alternate. Stewart stated she and McLaughlin will be attending the NYACD Annual Meeting in October. She also stated that she and McLaughlin will be attending the NACDE Annual Meeting. McLaughlin and Halloran will attend NACD in Maine. Stewart stated we will revisit accepting the 2023 Committees at the November Meeting.

- b. New York State Fair Committee White submitted her report, appended to the minutes. She stated next year there will be a new theme "What Districts do" and promoting "working for Districts". The committee is looking for suggestions on how to get more District folks to volunteer. This year there were three shifts with no one at the booth and seven shifts with only one person. Yaw suggested sending out the volunteer signup sheet earlier. Stewart asked if anyone took advantage of the lodging reimbursement. White stated she did not believe so. Stewart stated she noticed a lack of vendors at the fair. She staffed the booth for a shift and talked to hundreds of people and handed out brochures of what the Districts do. She thanked Wayne County for putting the brochure together. White stated promotional items ran out very quickly as they have a limited amount of money in the budget for these. She would like to double what they can give out per shift if the CDEA will increase their budget for next year. Stewart and Burke stated they ran out of promotional items in the first two hours. Next meeting is October 2nd where they will work on next year's budget. Stewart suggested that her and White talk after their meeting about what the committees' needs are since there is a lot of money to be spent with 4-Hour Online Funds. She also stated that she does not think the CDEA booth should be moved as many people look for us there. Stewart thanked White and the entire State Fair Committee for all their incredible hard work and dedication.
- c. **NYS DEC Endorsed 4-Hour Erosion & Sediment Control Online Training** White submitted her report, appended to the minutes. She stated that Monroe County SWCD has a policy in place and takes a 5% credit card fee for anyone who requests a refund and had used a credit card. The credit card fee for a refund is \$12.50. The platform has

- been put on the backburner as there has been too much going on. It is up and running just not live. They are looking for volunteers to evaluate it out from start to finish to work out any glitches that they might have. Stewart stated that it is a great purchase and will make White's job easier.
- d. **NYS Erosion and Sediment Control Certificate Program** Verrigni submitted her report, appended to the minutes. Stewart stated that the committee is working on a review packet, and it will hopefully come out in October. Stewart had a conversation with Verrigni on when would be the best time to hold a review course and she stated early November would be a suitable time and another one will be planned with date and location to be determined by the committee. Stewart and WhitKovits plan to take the course and become instructors. Stewart encouraged everyone to take this course either online or in person. It is great knowledge to have and will bolster your credentials.
- e. **Frank Bratt Scholarship** Campbell shared her report, appended to the minutes. Changes were proposed to the application. A "total course fee" line was added, and the contact information was edited.
 - A motion was made by Yaw, seconded by Ferry to approve the updated Frank Bratt Scholarship application per the appended document. Carried.
- f. Conservation Skills Workshop Eskildsen submitted a report, appended to the minutes. Kemmeren stated that she believes there are more registrants since Eskildsen created this report. She stopped taking registrations at 4:30 p.m. Stewart stated budgeted costs vs actual costs are still getting sorted out but may be quite a bit lower than initially planned. Fifty percent of the classes ended up being held away from the hotel making for a considerable difference. The committee will do an analysis of planned costs vs actual after the workshop to determine future funding needs.
- g. Water Quality Symposium McLaughlin reported she reached out to all the committee chairs this week. Courses and instructor names are due to her September 20th with descriptions of courses due October 20th. She met with each committee last week. She met with Linda at DoubleTree and the contract is set in place. Stewart and McLaughlin will review it. Linda was able to increase our reserved rooms from 150 to 200. Linda will contact nearby hotels and inquire if they provide transportation to and from the venue and if they have government rates if the Double Tree runs out of rooms. Linda suggested moving the awards banquet to the room where opening ceremony takes place as this is a larger room than banquet room. Still hold the cocktail hour in the little room by the current banquet area and then move down the hall for dinner and awards. Stewart stated that sounded fantastic and then we will not have to worry about limited amount of seating. Yaw mentioned this larger room is also closer to the basket raffle and silent auction room. Stoddard complimented McLaughlin on the fantastic job she is doing with organizing the Water Quality Symposium and stated that the Director of the Ranger School reached out to her and that they are planning to send students to the conference.

 A motion was made by Stewart, seconded by McLaughlin to waive the course registration fee for college students to attend the 2024 Water Quality Symposium, and to charge the room and meal fee. Carried.

White stated they have a large number of orange polo shirts leftover from the State Fair and Empire Farm Days booth and want to get rid of them. The committee is interested in selling them at the Water Quality Symposium if they are allowed to do that. Murphy suggested CDEA purchase these and give them away to new employees.

- A motion was made by Aldrich, seconded by Murphy to allow CDEA to purchase remaining fifty-nine shirts from the State Fair Committee in the amount of \$1,298.00, with funds returning to the State Fair Committee. Cuddeback abstained. Carried.
- h. Administrative Conference Lewis reported that the conference will be held November 6th & 7th at the DoubleTree in Syracuse. Most of the classes are set. \$75 per person to attend with hotel accommodation included. September 12th is next Zoom committee meeting. Miller is looking into possibly holding another paint and sip for entertainment as it was well attended. Stewart stated to keep her posted on the budget. White thanked Lewis for putting the conference together.

- i. New York State and NCF Envirothon Committee Kemmeren reported that a major sponsor for NCF Envirothon is NRCS. A contract has been signed for a sponsorship of \$400,000 to the event. She believes this is a good step in the right direction. Many Districts have not sent in their \$3,000 donation. Letters were sent out a few years ago requesting this donation. Bus Company has been contacted for the day trip and the Hobart and William Smith College has been secured for NCF Event. The 2024 State Envirothon will be held at SUNY Cortland. The last committee meeting was held there, and the committee toured the facility. The next committee meeting will be held next Friday, and she will share the meeting information for anyone that is not on the committee but would be interested in attending. Murphy suggested sending a list of Districts that have not sent in their donation to Division Reps and they can contact those Districts. Yaw suggested a letter to go with the invoice for the \$3,000 donation. Stewart asked how much registration per team for NCF event will be. Kemmeren stated she believes the New York NCF Envirothon Committee was given an increase for 2024 but does not know the actual amount. White asked how soon NRCS would pay and how far will \$400,000 go. Kemmeren stated they have agreed to pay half upfront, and then as expenses are incurred, she will invoice for reimbursement. Kemmeren stated the \$400,000 cannot be used for certain expenses. White asked if there was a dollar amount for how much more they need and does CDEA have a plan for where this money is coming from. Kemmeren stated she missed the last meeting and has not sat down to discuss how much more money is needed. She believes NRCS will cover lodging and meals but not 100% sure what else. Halloran stated NRCS money will cover rooms, food, and educational things but not outings that are on the fun side. Stewart shared a document she received that shows NRCS contribution broken down to what they will be able to support. They can contribute college, transportation, opening ceremony, education might be allowed, liability insurance might be allowed. White asked if laptops still need to be rented. Stewart stated Miller is working on this and laptops will either be free or at a low expense. White asked as the bills come due will you have this money in the bank or will you be getting it after the fact. Kemmeren stated she hopes she will have the money as the bills come in, but she does not know.
 - A motion was made by Stoddard, seconded by Yaw to approve the following 2023-2024 New York State Envirothon Committee members: Victor DiGiacomo, SWCC; Natalie Shudt, USDA NRCS, Registration/County Coordinator; Karl Strause, NRCS, Test Coordinator, Volunteer Coordinator, Site Coordinator, any committee; Robert Shenk, volunteer; Scott Fickbohm, SWCC, any committee. Carried.
- j. **Environmental Education Foundation Committee** Stewart shared a report from Miller, appended to the minutes.
- k. **New York State Invasive Species Advisory Committee** Stewart reported she will be attending the next meeting on September 26^{th,} and she will let committee know what

- Districts are up to.
- Municipal Assistance Sub Committee Stewart reported there were no current updates.
- m. **Technical Advisory Committee** Stewart stated there were no new updates.
- n. **Recruitment and Retention Committee** Stewart reported as talked about yesterday the New York State Fair is a wonderful place to get the word out what we do and job opportunities. She spoke with fifteen students about Conservation District jobs at the New York State Fair and disseminated the job brochure as well as handed out business cards.
- o. **Northeast Association of Conservation District Employees** No report. Parker mentioned he is seeking nominations for awards.
- p. National Association of Conservation Districts No report.
- q. **Operations Manual Committee** Stewart reported that SWCC is taking the lead on updating this manual. They may bring it up at the Administrative Conference. It is a one stop shop on how Districts should be run. It is a great tool but needs to be updated.
- r. **Leadership Conference** Stewart stated this is a placeholder as the next conference will not be held until 2026. Aldrich suggested a save the date be sent out months prior to conference so employees can plan for it since many plan vacations during the summer and it is in the middle of construction season.

VI. CDEA activities

a. Solar and wind projects on farmland discussion – Stewart mentioned that there has been a lot of discussion pertaining to solar and wind projects on farmland. At the August meeting a District Director brought forward his concern about the installation of wind and solar projects on prime farmland. Madison County SWCD is going to bring forward a resolution for consideration at the upcoming annual NYACD meeting in October. At a Finger Lakes Lake Ontario Watershed Protection Alliance meeting in November, some Districts mentioned that they are involved with solar and wind projects on farms. SWCDs submit permits with stormwater pollution prevention plans and assist farmers with stormwater pollution prevention and erosion and sediment control practices. Stewart sent out a statewide email polling Districts to see where they stand on the issue of solar and wind projects on farmland. She received great feedback, appended to the minutes. Stewart thanked Murphy for the formatting of the polled responses as most of them were from his Division. Halloran asked if the companies will not ever state that solar are irreversible. Stewart stated yes. Murphy stated we should have a greater involvement in the planning process and work with local municipalities on educating them on the issues we have. Halloran stated that American Farmland Trust is a great resource for solar and wind projects as they have done a lot of research on this. Yaw asked what happens when they are done with the solar projects. Stewart replied that's a good question. Aldrich stated that New York should follow Massachusetts where solar panels are higher off the ground so you can mow under them. New York could make the landscape look better than they do with the installation of the solar panels and the fencing. She stated Europe

is farther ahead than NYS in agriculture and solar power. Yaw stated Jefferson County just experienced their first fire on a solar project. Klemczak stated that residents in his county are expressing concern on loss of deer habitat when these solar companies are installing tall fences around land deer's living space. He wondered if the entire project must be fenced out. Stewart stated when she was at the State Fair Booth, she talked to a couple of farmers from Herkimer County where the solar power companies pitched that solar power panels installation is improving pollinator habitat. Also, stated that the income they receive from the solar companies is more than what they would get to keep land in production. At the last NYACD meeting, Sam Casella stated he sits on the NYATWG (New York Agricultural Technical Working Group) committee that is dealing with solar and wind projects on farmland. Stewart asked Bzduch about this committee and she stated it was an advisory body providing advice and guidance to help steer efforts to advance renewable, primarily solar, energy development in responsible ways while appropriately balancing the needs and contributions of NYS agricultural operations, land, and farmers. This group is comprised of farmers and ag land advocates, solar industry, local and regional government, non-agricultural governmental organizations such as agriculture and clean energy, academic experts, and state agencies. NY SWCC is not directly represented on this committee but Mike Latham who is the Director of the Division of Land and Water Resources is a representative and Brian Steinmuller has attended these meetings in the past. This group is led and coordinated by NYSERDA and as far as she knows Districts have not been invited to sit on this committee or attend meetings. Jason Mulford is umbrellaed under Ag and Markets, and he is working on issues like these. He presented last year at the Managers Meeting and Stewart will invite him to the November Meeting. She remembered Mulford stating that this land is the landowners, and they can do with it whatever they want, and Districts should keep this in mind. Nichols reported that Schoharie County passed a resolution to increase the application fee for solar projects from \$500 to \$20,000 which weeds out companies that are not serious and bog down the planning board. Knapp stated the State put out a template and that his town bumped up their application fee too. He wondered if this is a NYSERDA push right now, and if they are funding some of the companies that are contacting landowners. He knows NYSERDA is hiring some of these private companies to work with local municipalities to be proactive in the process. In the Town of Otisco, there is going to be a large turbine project installed. Lewis stated his SWCD plays no role with solar but have helped local towns with GIS mapping and the support they need. Stewart asked if there is a need for representation on NYSATWG. Aldrich asked if Casella would be representing Districts' concerns since he is representing NYACD. Stewart stated Casella is a farmer and NYACD representative, so she does not know if he does or not. Lewis stated you need someone with technical abilities when they talk about solar and wind projects. He suggested reaching out to Casella to let him know that District staff would be interested in sitting on the committee. Stewart stated it is a detriment if no District staff are sitting on this committee. Lewis stated as CDEA you will always have opposition with a wide array of opinions. Halloran stated that most Districts will agree it is a threat to prime farmland. Aldrich asked if towns benefit from

solar projects. Knapp stated his town said the county receives the commercial tax but not towns. Cuddeback stated that they have completed a bunch of soil group worksheets where they have to exclude any land that has solar panels on them as they do not quality for Ag assessments. Murphy asked if NYACD knows about Madison County's resolution and Monroe County's Legislative Bill. Stewart stated they were not brought up at the last meeting.

A motion was made by Murphy, seconded by Stewart to share Conservation
 District feedback regarding solar and wind development on prime farmland with
 NYACD at their September meeting, and request that these comments be shared
 with the NYACD membership. Carried.

Stewart will take the comments to the September NYACD meeting and will see if the Senate Bill 1739 is on their radar and ask if they will take a stand on it based on the comments received. She will provide an update at the November meeting. She thanked Districts for taking the time to respond to the poll. She will ask Jason Mulford to attend next meeting and give a presentation.

- b. Purchase CDEA promotion items Stewart stated that Burke mentioned that there is a Promotional line item in the 2023 CDEA budget for \$5,000 to purchase promotional items to giveaway at college fairs, Districts, WQS resource fair, or CDEA branded shirts or hats for the board. She asked for input on what should be purchased with this money. Stoddard mentioned the Ranger School and ESF college fairs coming up where she would like to send them something. Aldrich stated she would like the state committee annual reports sent to these colleges. Stewart suggested if SWCC would send them a pdf of the annual report the CDEA could pay for the next printing. It would be a valuable document for the students showcasing all the types of work the Districts do to get them excited about possibly landing a job or internship with a District. Knapp stated he would look into who oversees the annual report and ask them to send Stoddard the pdf file. Stoddard stated the printing service she uses would be able to print these reports in just a few days. Stewart stated she would like CDEA apparel with the cool logo we have. Aldrich stated that Franklin County SWCD has sharp black polos. Murphy asked if you could set up a shop where people could pick what style shirt and color they like. Stewart stated yes you can do that through Clear Image who she orders apparel for her District through. She suggested each person can order two shirts. Murphy suggested a \$100 per person limit on apparel and everyone could choose what they like. Stewart stated she would send out Clear Image website and people could look to see what they offer. Lewis suggested offering this statewide to District employees who are interested in purchasing apparel on their own.
 - A motion was made by Stewart, seconded by Aldrich to expend \$1,000 for additional printing of NY SWCC annual report and \$100 each for the Executive Committee Members and Division Representatives to purchase CDEA apparel. Carried.

- c. 4-Hour Fund application review and approval Stewart reported three applications were received. One application did not qualify to use funds to attend Conservation Skills Workshop. This goes against our policy. 4-Hour funds are already going towards supporting these trainings in terms of hiring trainers, discounting hotel rooms, discounting registration fees, and paying for the venue in advance. It is against the policy to pay to send individuals to trainings like Conservation Skills, Water Quality Symposium, Administrative Conference and Leadership Institute. Murphy stated he heard from one county interested in applying for money to attend Conservation Skills Workshop. Cuddeback stated when he read the policy, he thought you could apply for those types of trainings. Lewis stated that last year one application was turned down for the same reason. Stoddard stated in her Division counties have had questions on this 4-Hour application. Murphy suggested offering one person per District to attend Conservation Skills Workshop for free in the future, like we are currently doing with the Water Quality Symposium. He added that the Conservation Skills Workshop Committee could remind the CDEA Board of this next year. Nichols asked whether Frank Bratt Scholarship could be used to pay for Conservation Skills Workshop. Murphy stated no. Stoddard suggested that Division Reps should be encouraging employees to apply for the funding for training to diversify their skill sets. Stoddard reviewed the application for the Silvopasture training that is a modified training like the silvopasture training Cornell held last year but will focus mainly on planning. They are asking for registration fees and 2 nights of accommodation be covered for up to 15 District employees. Stoddard and Kristin Ballou both attended the training last year and take a big interest in this and there is a lot of interest in this in their counties. Stewart asked how this training will benefit districts statewide. Stoddard stated it will give technicians the skill set to talk to farmers and be trainers in the future. Murphy asked if this was open to all District employees statewide. She stated this course is open to anyone. Cuddeback asked how much registration fee is. Stoddard stated \$65 and she estimated \$200 for the hotel room. An announcement will be sent out statewide and anyone interested can contact Ballou and she will get them signed up and pay for everything and invoice CDEA for reimbursement. Ballou has already reached out to people she knew who have expressed interest. Murphy asked if they are guaranteeing them those fifteen slots and is there was an opportunity to increase slots for more than 15 District employees if there is interest. Knapp replied that the training was only allowing thirty participants. Stewart stated that for last year's Silvopasture training they filled fifteen of the twentyfive slots.
 - A motion was made by Murphy, seconded by Halloran to approve the Use of Funds Generated from the New York State Department of Environmental Conservation Endorsed 4-Hour Erosion and Sediment Control Online Training by a Conservation District application submitted by Warren and Franklin County SWCDs for a Silvopasture Training for Professionals in the amount of \$6,900.00.
 Stoddard abstained. Carried.

Peruzzi suggested rewording #1 on the 4-Hour online fund application as its confusing. Emerick stated that CDEA is allowed to give credit to each District for employees to attend Water Quality Symposium or Conservation Skills upon approval from the CDEA Board. Stewart stated we will update the policy to make it clearer and add it to the agenda for November. Stewart asked if there was a need in Seneca County's budget to have this funding to send employees to Conservation Skills Workshop. Peruzzi stated it is included in their budget but if they could use 4-Hour fund money for the workshop they could utilize the money in their budget for something else. Stewart thanked Peruzzi for calling in.

 A motion was made by Stewart, seconded by Murphy to deny the Use of Funds Generated from the New York State Department of Environmental Conservation Endorsed 4-Hour Erosion and Sediment Control Online Training by a Conservation District application for 2023 Conservation Skills Workshop because it is going against the policy. Carried.

Stewart stated that Kristin White has been doing a phenomenal job with the CDEA website but is ready to hand the duties over to someone else. The current website and domain name is already housed by GoDaddy which should make the transition smooth. Stewart has been working with GoDaddy developers on her District's own website. She proposes she does the same with CDEA's website. It should be a simple transfer of all the data that is on the website, cleaning up the menu and making sure to integrate Square. Lewis stated that any individual can go onto our website and pay to attend the 4-Hour Online class. It needs to have a password or something for District access only. Kemmeren stated she can go on and make items inactive in the Square Store for instance Conservation Skill Workshop. She stated the only ones active in Square are Frank Bratt donation, Conservation Skills Workshop and one other. The rest are hidden or inactive which she can change. The cost to GoDaddy for the website and integration of Square store is \$2,831.27. She will attend a multiday training and GoDaddy would transfer the old website to the new platform utilizing a template to make it look sharp and to make sure it is ADA compliant. It should be an easy transformation. It will go live after several emails and meetings going through the content of our website. Murphy asked if the \$2, 831.27 was only for GoDaddy and nothing for Stewart's time. She responded yes; she does not need anything for her time. Emerick stated she loved the idea about the website and updating it and it is a long time coming to make the website better. She asked if you will still be able to update this on a regular basis. Stewart stated she will have full access to the website in which she will be able to make updates in a timely manner and it will be housed in CDEA and not GoDaddy. Emerick stated updating the website is a Division II responsibility and White has been updating the website. White stated moving forward she had to add to accommodate the 4- Hour course platform and Stewart will have to make sure this gets done. Stewart thanked White for

hosting our website for so many years.

- A motion was made by Yaw, seconded by Cuddeback to approve the Use of Funds Generated from the New York State Department of Environmental Conservation Endorsed 4-Hour Erosion and Sediment Control Online Training by a Conservation District application submitted by Hamilton County SWCD for CDEA Website Development in the amount of \$2,831.87. Stewart abstained. Carried.
- d. **Proposed draft amendments to District Law Update** Nothing new to report.
- e. **NYS CDEA Inc. By-Laws update** Stewart reported that she will work with McLaughlin and Murphy to update the bylaws to be reviewed and preapproved at the January CDEA meeting. The preapproved draft will then be brought forward for approval at the CDEA Annual Meeting in March at the Water Quality Symposium.
- f. **Management Development Certification Program** Stewart reported she reviewed the By-Laws, and this program is overseen by the Member of Large, Halloran. She suggested Halloran to reach out to Doug Kierst for his ideas on moving this program forward as he has gone through the program and helped develop the program.
- g. Ronnie Raindrop Stewart reported she did not have time to investigate lumpy Ronny costume. There is funding in the budget of \$9,500 to purchase costumes for even Divisions. Kemmeren stated that \$12,000 was expended for the costumes made last year. Stewart stated she took the costume remake over and it took a long time to get costumes from the company she contracted with and there are issues with the costumes and shoes. She recommends going with another designer and starting fresh. Stoddard volunteered to take on looking for a new costume designer for the costumes and get quotes. She asked if this did not happen this year would the money roll over to next year. Stewart stated yes.
- h. **5-Stand Tournament** Burke reported that a flier was emailed out statewide and to all our partners and the date has been set for Thursday, October 12th at Vernon National Hunting Preserve. Deadline to enter is October 6th. This event will be held rain or shine. If there are not enough participants, we can cancel up to October 6th. If people are interested but cannot find four more to fill a team, they can contact Joann. Cost is \$100 which includes ammo, targets, ear and eye protection, bottled water during the event, and lunch. Lunch will consist of hamburgers, hot dogs, salads, and drinks. CDEA will provide a cookie tray for dessert. Warmups are available at \$.75 per target. Discussion was made of giving cash prize to winning team. There will be a 50/50 raffle as well. Discussion was made of awards and Lewis stated he could help Burke with that.
 - A motion was made by Cuddeback, seconded by Murphy to approve up to \$50 in expenses for the 5-stand tournament. Carried.

Murphy suggested giving District employees who attend the 5-Stand Tournament an orange CDEA polo fair shirt for participating. Stewart asked how many shirts were left and how much. White stated there were fifty-nine shirts for \$1,298.00.

Murphy stated in Joann's correspondence to state that they do not need to have a team to register. They can contact her, and she will have a list of individuals needing team members.

- i. **Fish On Challenge** Stewart shared WhitKovits report. Dust off that fishing pole and sign up for the CDEA Fish On Challenge! Do not be afraid to be creative with your submissions. Categories are for Smallmouth Bass, Largemouth Bass, Northern Pike, Trout Special, Comradery Catch (for the spirit of friendship and good times with family) and Jokers Wild (must include why fish is unique and why it should win). Submissions can be made any time before February 28, 2024. Submit your entry including your name, date caught, species, length, waterbody location, and a picture of the fish with you or a measuring tape to Google Forms or Fishcdea@gmail.com.
- j. **CDEA Golf Tournament** Stewart stated she did not receive an update from Doug Kierst but if anyone did, please give an update. Burke stated she thought there were eleven teams, and it was a fun time. A few golf carts had technical issues operating in the rain. Lewis stated it was a very wet day but a wonderful time. He stated that the winners and the losers were the same as last year. McLaughlin stated their team came in second to last.
- k. **2 Hour NYS DEC MS4 inspector training program for Districts** No movement until new MS4 permit is issued. Emerick stated that the permit has been held up by the executive level at NYSDEC for months. She is not sure what the issues are. Will not see anything happen this year. Have been waiting since 2015.

VII. Other Business

Stewart stated that the entire CDEA Board assists with Water Quality Symposium that McLaughlin is organizing. The Board is so involved from sitting on class committees, helping organize instructors, teach classes, make sure registration booth is staffed throughout the entire event. She suggested that the entire Board should attend the week for free. Yaw asked if this will be in addition to the two coupons each District will receive. Stewart stated yes.

- A motion was made by Ferry, seconded by Murphy to pay for all the CDEA Executive Board and Division Representatives to attend the Water Quality Symposium for the entire week for free. Carried.

September 6, 2023 NYS Soil and Water Conservation Committee Report

NYS SWCC Meeting: Next NYS SWCC meeting will be held on September 19th. One in-person location will be offered at the NYS Department of Ag and Markets in Albany. A virtual call-in option will be offered. Researchers from Cornell University will be presenting on their work to establish soil health benchmarks per the Soil Health Climate Resiliency Act. We are also planning to present the ranked list for Round 29 Ag NPS Program for approval.

NYS SWCC Advisory Member and Partner Project Tour: Tentatively planning to host a NYS SWCC Advisory Member and Partner Project Tour in Ulster County on October 12th. Determining the level of interest before firmly committing to the date.

AEM Base Round 18: An e-mail was sent to Districts on August 29th, 2023 from Greg Albrecht announcing Round 18 of the noncompetitive AEM Base Program. Two year AEM Action Plans are due November 1, 2023. The contract term for Round 18 projects will be January 1, 2024 to December 31, 2025. A webinar will be held from 1:00 PM to 3:00 PM on Tuesday, September 12th to discuss AEM 18 changes and field any questions from Districts. State Programs Advisory Committee: the NYS SWCC will be creating a new sub-committee – State Programs Advisory Committee. The purpose of this advisory group will be to discuss NYS SWCC programs, gather program ideas and feedback, develop and update a list of sole source technical providers, and collect priority areas for special project funds and input about methods to allocate those funds. The Committee will be comprised of SWCC staff and Soil and Water Conservation Districts and will further support decision making at State Committee Meetings. We are hopeful that this platform will provide more opportunities for Districts to be involved in the development of new and existing programs. More details will be shared as they become available.

- Currently implementing two AEM Tier IV Implementation projects, both of which are silage leachate management systems.
- Completing in stream evaluations on two major watersheds, Buffalo Creek and Wiscoy Creek, to assess for major erosion sites and invasive species infestations
- Projects in design for this year:



Division Updates:

A busy summer, I'm sure for all.
There have been some feedback
emails going back and forth in our
Division and I will share some of
that with you after the County
Updates.

At the last NYSCDEA meeting, board member composition – in particular the Grange representation was discussed. I worked with the folks at the NYS Grange here in Cortland and secured their most recent membership list showing the active Granges, by county, with contact information. The list has been shared with Scott Fickbohm and will be posted on SharePoint for SWCDs to reference when a board vacancy arises.

Lastly, a Division IV meeting is being planned for the end of October/beginning of November – CPR/First Aid, Updates, and a couple of new topics brought up in a division wide poll sent out after WQS 2023 – anticipate additional funding beyond the budgeted amount will need to be utilized.

County Updates:

Cortland County: We said goodbye to our buffer and AIS steward, Cody.....best of luck! Stream projects are in full swing, surveys are happening, geologic investigation with folks from Tioga and NRCS soil scientists, NYS Fair, Cover Crops are upon us, trying some new planting mediums through the old' hydroseeder, budget season, countless CAFO inspections, Grant deadlines – take home: a lot of business as usual with a flair of newness and just a feeling in and around the office of being very, very busy! Fall is right around the corner.

Thoughts, Questions & Discussion Items

- 1. Solar the question posed by Caitlin was shared Division wide and responses were shared back to the CDEA board in an email on 9/5/23. This is a discussion item on the meeting agenda.
- 2. Regarding CRF Back in May, we brought up some CRF carve out questions, in July we discussed the potential development of a RFP process for research topics related to CRF, having an application process and Districts being eligible applicants. Some of those conversations have again come up does the NYSCDEA support a research carve out from CRF? If so, what could or should it look like If research projects are being proposed by other agencies, where does the District fit in are others utilizing a farm a particular County SWCD has a good working relationship with? Can this be applied research Districts should be working and learning right alongside these folks and maybe not sitting idly by waiting for half a decade to see a report published on the results. Should outside agencies write into the proposal how the District can/will be involved in their research projects/ideas? For proposals from Districts, should they get points for involving

others? Maybe the carve out doesn't actually need to exist – maybe the research component can be built into actual physical "projects" and maybe there could be some "point" mechanism included that helps with that project ranking. Looking at this research component, right now it seems that the process is non-competitive while Districts are put through a competitive application process.

3. Back in may I mentioned that in Round 6 a sub-committee was formed to discuss the CRF program; the increase in funding coming and how Districts thought it should be divvied up, by tract with focuses on different practices, etc. Last round we saw an explosion in eligible projects and practices and many questions still remain – a sub-committee is likely still needed, but not just for CRF. Coming out of Covid, communication has been improving, but ensuring policies and procedures related to all District programming administered by the SWCC continues to be a priority – input from the boots on the ground (SWCDs) is important. Sure there is the technical side of things, TAC, but an involved voice regarding program and policy development, continues to be important aspect as well.



Schoharie Stream Restoration - A 10 Year Review

Pete Nichols, District Manager Schoharie County Soil & Water Conservation District

This session will include highlights on a variety of stream bank restoration projects, including failures or challenges that the District has faced, including highlights of large scale, post flood, and small scale projects.

Stormwater BMP's in Agriculture

Erosion, Sediment Control and Stormwater Training

Under the NYS Department of Environmental Conservation's Stormwater Permit, <u>all construction site contractors and subcontractors must have at least one "trained individual" from their company on their construction sites on a daily basis that is responsible for implementation of Erosion Controls and Stormwater Management. These individuals must complete this 4 hour training every three years to remain certified on the principles and practices of erosion and sediment control and stormwater management.</u>

This training covers both technical and regulatory aspects of stormwater management and erosion control, and is open to anyone including municipal officials, developers, contractors, non-profit organizations, and others.

With this presentation the NYSDOS is allowing four (4) Professional Development Elective (PDE) hours for municipal officials who attend this training.

The New York State Soil & Water Conservation Districts 2023 State Fair Booth August 23, 2023 – September 4, 2023

I received a phone call from the State Fair asking if we would consider moving to a different location within the Horticulture building.
