

Erosion & Sediment Control Training NYS DEC-endorsed 4-hour GP-0-20-001 December 10, 2024 8:30am – 1:00pm



Under the NYS Department of Environmental Conservation's Stormwater Permit GP-0-20-001, all developers, contractors and subcontractors must identify at least one *trained contractor* from their company that will be responsible for implementation of the SWPPP, and have at least one *trained contractor* on site on a daily basis when soil disturbance activities are being performed. Also, developers must have a *qualified inspector* conduct regular site inspections in accordance with GP-0-20-001.

Code Enforcement Officers & Planning Board/Zoning Board of Appeals members may use this course as 4 hours of Professional Development Elective Credits. The individuals completing the training may also need to provide DOS with a copy of their wallet card or certificate of course completion, if requested.

*Qualified inspectors and trained contractors must have 4 hours of training in the principles and practices of erosion and sediment control endorsed by NYS DEC, SWCD, NYS Erosion & Sediment Control Certificate Program, or CPESC, Inc. Training is good for 3 years. Training is **not** required for CPESC, LA, NYSE&SCCP, and PE certified persons. Upon completion of the course, each participant will receive a NYS DEC Stormwater Training Number on a certificate and wallet card good for 3 years. Certificates and wallet cards will be issued to trainees after the class is held.

This training does not allow contractors to conduct their own Qualified Weekly Inspections.

LOCATION:

Virtual Class via Zoom – Each student <u>must have a camera</u> on their computer, tablet, or phone and an internet connection. Screen shots of the attendees will be conducted at the beginning of the course, every hour thereafter, and at the conclusion of the course. <u>Students attending must not be working i.e. on a job site, driving, or performing other</u> <u>work duties during the virtual training</u>. If this is observed by the instructors, the student will be removed from the zoom course and will not receive a training certificate.

A ZOOM training registration link will be emailed to the attendee no later than one *day prior* to the class.

COST: \$100 per person, non-refundable

The New York State Soil and Water Conservation Committee (SWCC) is excited to announce the release of the 2023 NYS Soil and Water Conservation Committee and Agricultural Environmental Management (AEM) Annual Report. This report encapsulates the work of the SWCC, AEM program, and Soil and Water Conservation Districts (SWCDs) for 2023. Below we have summarized just some of information the you'll find in the report.

2023 NYS Soil and Water Conservation Committee and Agricultural Environmental Management (AEM) Annual Report Highlights:

In 2023, SWCDs responded to:

- 11,709 requests for technical assistance regarding water quality related concerns (i.e., eroding streambanks, runoff issues, permit applications)
- 2,194 requests for stormwater management assistance (i.e., conducting site visits, developing stormwater management plans, conducting contractor erosion and sediment control trainings, etc.)
- 11,913 requests for technical assistance regarding land use management issues
- 3,245 requests from municipalities to provide technical advice

In 2023, SWCDs completed:

- 224 stream and shoreline stabilization projects and 753 flood mitigation projects
- 23,139 acres of forest management and 87 forest management plans

- 135 invasive species management projects to restore 5,250 acres of land
- 1,128 septic tank upgrades or replacements

Education and Outreach Events Completed by Soil and Water Conservation Districts (SWCDs) in 2023:

- 50 county or regional Envirothon events
- 48 conservation field day events
- 67 education programs
- 15 Earth Day events
- 69 conservation project tours
- 47 soil health and pasture training events

On the Farm STEM Inspires NY Science Educators Troy Bishopp



An On the Farm STEM professional development event, hosted by the New York Beef Council, provided eighteen dedicated middle and high school science educators with practical agricultural experience into the beef and dairy industries was held in Oneida and Lewis County.

Participants visited Simply C Farm in Boonville, exploring the beef lifecycle and learning about grazing principles from Troy Bishopp of Madison County SWCD, soil health principles from Oneida County SWCD Ag Intern, Hayleigh Gates, and forestry careers and initiatives from District Forester, Jessica Pyrda. Ronny Raindrop was on hand to help with chores and demonstrated the water infiltration test for teachers.

The program continued with a visit to Beller Farms in Lewis County, where attendees explored engineering and technology used in modern animal handling and care.

The session showcased the latest agricultural innovations, demonstrating how technology is applied to improve efficiency and animal welfare and how the farm works with Lewis County SWCD. The "On the Farm STEM" trainings are a Beef Checkofffunded program produced by the American Farm Bureau Foundation for Agriculture, a contractor of the Beef Checkoff, that helps STEM (Science, Technology, Engineering, & Math) teachers develop curriculum for their classes using food and agriculture as a vehicle for scientific learning and development.



Schools engaged to restore local waterways

Since 2016 the Upper Susquehanna Coalition (USC) has been coordinating the Department of Environmental

Conservation (DEC) Trees for Tributaries Program (T4T) within the headwaters to the Chesapeake Bay. It started out slowly; mostly district staff were doing the planting, and we only offered the program in spring. Getting

volunteers engaged with the program had been difficult and when we were able, volunteering mostly took place on the weekends.

Fast forward to 2024 and the USC is offering the program in both spring and fall, and more volunteers than ever are asking local SWCDs if they can participate! Better yet, we've been able to engage with a diverse range of volunteers within working hours during the week, accelerating the number and type of volunteers involved. As an example, school clubs and courses have been working with us to make tree planting a part of their school day. This past spring, efforts

resulted in 191 volunteers coming out, committing over 1,000 hours to streamside tree planting. Here are a few examples of how schools have been working with us this

fall:

Morris Central School teachers have engaged in Bay Watershed Education and Training (B-WET) where they have been able to engage with the USC on environmental education within their local communities yet connect it back to Chesapeake Bay (Picture 1). Mt. Markham High School Future Farmers of America (FFA) club came out to help reconnect a stream channel with its floodplain- they really put some muscle into willow staking and tree planting (Picture 2)! Lastly, Owego Free Academy students have been ongoing volunteers, but recently planted trees to get credit for their Participation in

Government requirements. These students worked alongside NYSEG employees recently (Picture 3). Other schools are regulars too- such as Newark Valley Central School and Waverly Middle and High School students. The events that are being held during the week have been inspiring to both the participants, but also to SWCD employees. The kids are paying attention and are engaging with what is going on, really recognizing that their activities are part of something bigger.

The student's participation is mutually beneficial. While they learn about the environmental impacts of their activities that day both locally and as it relates to the Chesapeake Bay, they also learn about the career paths available for them in the environmental field. We'll hopefully see them all again for Envirothon, and then later in spring for tree stewardship! We're looking forward to making more connections with schools in the future to help with Chesapeake Bay and New York State afforestation goals.

Creek Willow Staking Project

CCSWCD staff along with NYS DEC and CCE have been observing Sleeper Creek in the town of Millport

for the past few months. After multiple field trips to observe the area, stream bank erosion was apparent in multiple locations. When erosion occurs along stream banks, there are often negative ecosystem impacts like sedimentation, thermal pollution and habitat degradation at and downstream of those sites. With the help of GST BOCES interns, SWD staff opted to deploy live staking with willow as a method to help control the erosion issue.

The process included taking live willow cuttings (< 1" in diameter) and driving them perpendicular into bare soil along the stream bank. Willow cuttings make great "live stakes" for stream bank stabilization projects due to the plant's resiliency and ability to take root without the use of chemicals. Staking on its own helps keep the soil along stream banks in place, but the tree root systems that develop after willow staking anchors soil and restores fish and wildlife habitat. SWCD staff will continue to plant and monitor willows stakes as a successful means of erosion control in Sleeper Creek.




The following updates were provided during the last NYS SWCC meeting on September 17, 2024:

- All new FY2025 agreements are being completed. NRCS has a September 30, 2024 deadline to finalize each pending new agreement.
- Districts desiring to enter into new agreements should begin discussions with their NRCS Assistant State Conservationist for Field Operations (ASTC-FO).
- Please don't wait. If a partner knows they're interested in pursuing a new agreement with NRCS, begin working with your local ASTC-FO now. The first deadline for all documents required for new FY2026 agreements must be submitted by December 2025.
- There will be a second deadline for any agreements that are discussed with ASTC-FOs after December 2025. I have not received that date yet; it will be provided to me at a later time.
